A meeting of the Galeton Area School Board was held in the Library of the Galeton Area School District on February 27, 2018.

The meeting was called to order by Board President Bonita Stover at 6:30 PM.

Board Members and all others present recited the Pledge of Allegiance.

Mrs. Huck commented on school safety, referencing the recent school shooting in Florida. She shared an email with Board Members that was also sent to school staff regarding school safety matters and the many state and national discussions about school safety opinions and needs. There will be a staff meeting and a meeting with select high school students this week to discuss school safety and gain input about school needs.

Mrs. Huck also briefed the Board on the need to update security technology in the District—cameras, door entry systems, entryway configurations. These updates will be expensive; however, they are greatly needed at this time. The Board was supportive of the Administration investigating equipment, construction needs, and costs for possible improvements this summer.

President Stover asked for a motion to consider approval of the minutes from the February 12, 2018, Board Meeting. On motion of Mr. Bach and second of Mr. Cimino, the Board voted 9 to 0 to approve the minutes.
